The Contract Addendum is a part of the Contract Bid Documents and Construction Documents and shall govern the performance of the Work.

SPECIFICATIONS:

Article 2-1: INVITATION TO BID (Request for Proposal):

1. Clarification: Project Phasing – The furniture will be completed in (2) phases.

Article 2-2: INSTRUCTIONS TO BIDDERS:

1. Clarification: Bid Receiving – Installation does not need to be completed by union laborers.
2. Clarification: Bid Receiving – Installation will be completed during normal business hours (M-F 8am – 5pm)
3. Clarification: Building Site Conditions – Furniture can be delivered through the double-leaf automatic sliding front doors. The Youth Services Renovations occur on the Main Level. Use of an elevator is not required.

Article 2-3: Drawing Sheet I201:

1. Phase 1 furniture scheduled to be installed in Phase 2 may be delivered to the Phase 1 site with the remainder of the Phase 1 furniture. The Library will store and place these pieces in their final location when the project is completed.
