## III. Project Overview - UEG

- A. Parking Lot Improvements UEG
  - a. The work includes demolition and replacement of existing concrete drive lanes of the parking lot on the south side of the Library and replacement of damaged curb and guttering.
- B. Alternates UEG
  - a. Alternate #1 Provide new Roadway inlet and connection to existing storm inlet at NW drive entrance as indicated on drawings.
  - b. Alternate #2 Mill and overlay existing asphalt parking. Clean and seal existing cracking. Replace damaged curb and gutter as indicated on the drawings.
  - c. Alternate #3 Mill and overlay existing asphalt parking. Clean and seal existing cracking. Replace damaged curb and gutter as indicated on the drawings.

# IV. Project Scheduling/Phasing/Staging

- A. Project Start Up: Upon final legal approval of the contract.

  Start at the end of summer reading program August 4, 2025
- B. Substantial Completion Date:
  - 1. Substantial completion by October 3, 2025.
- C. Work hours: Construction activities may take place during normal hours of operation for the library. But as this is a library, loud activities such as saw cutting or messy activities like pouring concrete that would require extensive temporary flooring and any shutdowns shall occur when the library is not in operation. Please do not start work before 7am.
- D. Staging: Location shall be coordinated with the library.

#### V. Questions and Comments

- The coarse aggregate for all concrete shall be granite, quartzite or trap rock.
- PG 70-28 Asphalt Binder shall be used in all asphalt surface courses.
- Book return island remains. Curb is to be replaced as part of base bid.
- Erosion control as part of scope of work, inlet protection.
- City of Topeka requires Site Construction Activity Permit.
- Striping, Paint, etc by Contractor.
